#### Plan for better school education

Kolkata: The school education department has constituted an advisory council to plan a guideline for development, school education minister Rabindranath Bhattacharya said on Wednesday. The names of the council members would be finalised in consultation with CM Mamata Banerjee, the minister said. - BP

#### **Concrete chunk** falls off building

Kolkata: A concrete chunk fell from a three-storied building at Radhanath Chaudhury Road on Wednesday morning. There was no injury reported after the incident. Police informed the matter to the Kolkata Municipal Corporation (KMC). Primary inquiries revealed that earlier KMC authorities demolished had a portion of the building and remnants of the demolished building collapsed. – BP

## **Long-distance trains** to increase speed

**Kolkata:** The railway department has decided to increase the speed limits of some long-distance trains. The journey time of those trains would now be reduced by 15 minutes to one hour as confirmed by the Eastern Railway. Those trains are Dibrugarh Town to Howrah-Kamrup Express, Malda Town to Sealdah-Gour Express, Saharsa Sealdah-Hatey Bazare Express, Kolkata Garib Rath Express and Kolkata Radhikapur Express. The department also made a change of destinations for some trains. The Kolkata-Sealdah local would be changed to Baruipur instead of the existing destination of Sealdah. – BP

## New halt for **Patna Express**

Kolkata: The Patna Express will now stop at New Farakka and Kahalgaon stations on an experimental basis from July 1 to December, said Eastern Railway authorities. The department also hinted that the frequency of the Duronto Express could be increased. The Sealdah-New Delhi **Duronto Express frequency** will increase from bi-weekly to four days a week. However, the journey of four suburban trains was extended. The Howrah–Gurap local extended up to Masagram. The Prinsepghat-Habra local extended up to Majerhat, the Barasat-Prinsepghat local extended up to Ballygunge and Majerhat-Barrackpore local extended up to Ballygunge. - BP

Kolkata: Chief minister Mamata Banerjee is determined to keep her political commitment of returning land to the unwilling farmers of

Despite the possibility of a long legal battle delaying the process of returning land initiated by the state government looming ahead, a confident Banerjee on Wednesday instructed party MP and senior advocate Kalyan Banerjee to team up with advocate-general Anindya Mitra in the legal battle against the

"Anybody can go to court, it is his prerogative. No problem. The government has decided to return the land. We will hand over the land to the unwilling farmers. Land is in our possession. It was the decision of the West Bengal government following which a Bill was passed in the Assembly. It was in our election manifesto. We will go ahead with said Banerjee in the capital.

On her way to meet the deputy chairman of the Planning Commission, Montek Singh Ahluwalia, Banerjee reiterated that the process of returning land will not be delayed.

"The Bill is absolutely in accordance with the Constitution. Tatas may be angry. But it will serve the interest of the common people,"

said Kalyan Banerjee, who is also Mamata Banerjee's main legal "In this case, I am appearing for

The government took possession of the land by virtue of the Singur Land Rehabilitation Development Act 2011, a piece of new legislation aimed at giving back land to dispossessed farmers.

The Hooghly district magistrate stuck 54 notices on the factory gates since the first one was fixed on Tuesday evening.

The Tatas responded by hanging their own notice, stating that the firm needed at least five hours to react to any directive from the state government.



"Even employees of the factory were threatened with dire consequences," he argued.

"The project was almost complete. A trial run of the small car was on its way. Tata Motors was determined to roll out the world's cheapest car soon. But relentless agitation forced the company to scrap the project and leave Singur," Pal pleaded.

Pal prayed before the court for a stay on the notification which had asked the company to vacate the land. He also sought the appointment of a special officer to oversee the project area till "the case is disposed of".

On several occasions, there were heated exchanges between the counsels of the two parties. At one point, Pal's submission was interrupted by Mitra and Banerjee and the Bench had a trying time to pacify the two sides. The Bench will hear advocate-general Mitra's submission on Thursday.

# Look for profits, industry minister tells PSUs

Kolkata: Industry minister Partha Chatterjee Wednesday instructed heads of 13 state PSUs to prepare action plans for turning the organisations into profitmaking units without considering any steps to reduce staff strength. The minister met managing directors of the PSUs for more than two hours at Writers' Buildings. After the meeting, Chatterjee told the media: "I have asked each of them to submit to me a time-bound action plan on turning their units into profit-making units, making sure that the number of employees is not reduced in the process.'

The minister categorically pointed out that reducing the number of employees to cut financial burdens through different schemes such as voluntary retirement or a golden handshake was not an option.

When some of the PSU bosses raised the issue of deficiencies in technology, Chatterjee asked them to include specific technological requirements for increasing productivity in the action

plan. At the same time, the PSU bosses were told to inform the industry department the amount of bills of each of the PSUs that were pending with the government. "If it helps, I will request chief minister Banerjee and Mamata finance minister Amit Mitra to clear the bills as soon as possible," Chatterjee said.

The industry minister said that such review meetings would be held every three months to take stock of the progress.

# Tired of Left apathy, agriculture scientist shifts base to Orissa

Kolkata: Tired of the apathy of the Left Front government at the time, renowned agricultural scientist from the state Dr Debal Deb changed his base from Bengal to Orissa along with his 700 indigenous varieties of rice species. Some of these include species which are drought-resistant. After trying for years, he could not convince the government to provide him with four bighas to help him with the conservation of the rice species.

However, the new government has promised to look into the matter. "This kind of an incident is really unfortunate. Our government will try its best to provide him with the necessary help to bring him back to the state and help him with his work," said The **Bengal Post** 

Malay Ghatak, law minister with additional charge of agriculture. He added that if neces-

sary, the new government would have a talk with Deb to try to sort out the matter and ensure that he returns to in Bengal. "I have transferred and transplanted all my rice varieties to a farmland in Orissa. All my efforts and requests of acquiring irrigable land in my state failed so I decided to shift my base," he said.

He explained that out of the 700 species of rice, around 500 have been

collected from Bengal over a period of around two decades. Out of the 500, around 400 of the rice species need proper irrigation while the other 100 were drought-tolerant.

So, to conserve them, he had to look for conducive stretches of land, which he ultimately found in Orissa.

"I needed four bighas for conserving all the rice species I have. A stretch of land that costs around ₹5,000 per bigha was going for ₹15,000 per bigĥa. I do not have the luxury to spend around ₹60,000 per year on renting land," Deb said.

"This is a labour of love and I am not in a position to do business with it. But I need some minimum help from the government to preserve this labour of love. In bad times, this collection of mine would come to the government's aid and they should understand this," Deb said. He also criticised farmers for their present approach to farming. "Most of them have developed a very consumerist attitude. They think that they can always buy the rice varieties from the market, which is not true. When there was drought or other crisis periods, I supplied seeds to farmers in many instances but they never preserved them," Deb said.

After not getting the land, Deb finally shifted from Basudha --his erstwhile research centre in Bengal -- and went to Orissa. "If the government wants, then I will keep on providing the farmers with the rice and bail them out from crisis situations and serve when needed," Deb said.

Deb has already left the state but the bengal government is keen to bring
